General CDE/LDE Updates

Nature of Change

Virtual Preliminaries

Schools that have more than one chapter sharing a campus (example: middle school/high school or junior chapter/senior chapter) MUST sit for a virtual preliminary event at the same time.

Agricultural Issues CDE (HS)*

Nature of Change

Updated statement requiring competitors to show respect for all cultures.

Added a "Statement of Authenticity" requirement to be signed by all students competing on the team, i.e., "I certify that all materials presented here are of my own creation and that any work adopted from other sources is duly cited and referenced as such." – *signature*

Agricultural Technology and Mechanical Systems

Nature of Change

Safety Procedures

Students will be required to present a safety waiver at check-in to participate in the state finals.

Additionally, if an event official deems that a student is not safely demonstrating a skill, they will ask the student to stop and student will forfeit the points for that practicum.

Students should be prepared to convert decimals to fractions throughout the event.

Employment Skills LDE (HS)*

Nature of Change

Added a "Statement of Authenticity" requirement to be signed by the competitor, i.e, "I certify that all materials presented here are of my own creation and that any work adopted from other sources is duly cited and referenced as such." – *signature*

Environmental Science CDE (HS)*

Nature of Change

Updated GPS units that are allowed for use in the competition.

- GPS units that require an ancillary or third-party device such as cellular phone, ANT+ device, satellite communicator or any other stand-alone device to achieve communication or data sharing with other GPS units will be allowed for use in the event. All ancillary devices or technologies that a GPS receiver to engage in communication or data sharing with another GPS receiver are prohibited from the event.
- GPS units with any type of direct communication or data-sharing capabilities are prohibited from use in the ENR CDE. A GPS unit with "direct communication or data-sharing capabilities" is defined as any GPS unit that has the inherent ability to communicate or share data with other GPS units WITHOUT the use of an ancillary device or technology. This includes but is not limited to GPS units enabled with built-in two-way radio or wireless connectivity (e.g., cellular, Bluetooth, inReach Technology, a satellite communicator, or satellite subscription service) capabilities that allow direct unit-to-unit communication or data sharing.

Allergy Information Statement

Updated the Allergy Information as follows:

Allergy Information: Food products used in this event may contain or come in contact with potential allergens. Within the constraints of the event, reasonable accommodations for the nine recognized allergens (milk, eggs, fish, shellfish, tree nuts, peanuts, wheat, soybeans and sesame) and food intolerances can be made upon request. Advisors must submit a special needs request for participants with any allergies no less than THIRTY DAYS PRIOR to the event. The CDE superintendent will make all reasonable efforts to accommodate students with food allergies. However, Florida FFA makes no guarantee that we can secure and provide the requested accommodation for late and on-site requests.

Updated Objectives by adding "determining milk composition, and "Understand products made from milk, regulations and standards to ensure quality and safety, and marketing of dairy products and their alternatives to consumers."

Updated Milk Flavor to allow water as a palate cleanser and "Cooked" to the list of defects

Updated the Product Identification Dairy vs. Non-Dairy with chart identifying the product and relative fat percentage, and defining flavor added and commercially whipped products.
